Shareholder(s) or proxy(ies) or corporate representative(s) or attorney(s) are required to pre-register their attendance for the 87 th AGM to ascertain their eligibility to participate the 87 th AGM using the RPV. • Login with your user ID (i.e. e-mail address) and password and select the corporate event: (Registration) ORIENTAL 1936 BERHAD 87 TH AGM • Read and agree to the Terms & Conditions and confirm the Declaration. • Select "Register for Remote Participation and Voting". • Review your registration and proceed to register. • System will send an e-mail to notify that your registration for remote participation is received and will be verified. • After verification of your registration against the Register of Members as at 28 May 2024 the system will send you an e-mail after 2 June 2024 to approve or reject your registration for remote participation. 1.	Login to TIIH Online	• Login with your user ID and password for remote participation at the 87 th AGM at any time from 9.00 a.m. i.e. 1 hour before the commencement of meeting at 10.00 a.m. on Tuesday, 4 June 2024.
2.	Participate through Live Streaming	Select the corporate event: (Live Stream Meeting) ORIENTAL 1936 BERHAD 87 TH AGM to engage in the proceedings of the 87th AGM remotely. If you have any question for the Chairman/Board, you may use the query box to transmit your question. The Chairman/Board will try to respond to questions submitted by remote participants during the 87 th AGM. If there is time constraint, the responses will be e-mailed to you at the earliest possible, after the meeting.
3.	Online remote voting	 Voting session commences from 10:00 a.m. on Tuesday, 4 June 2024 until a time when the Chairman announces the end of the session. Select the corporate event: (Remote Voting) ORIENTAL 1936 BERHAD 87TH AGM or if you are on the live stream meeting page, you can select "GO TO REMOTE VOTING PAGE" button below the Query Box. Read and agree to the Terms & Conditions and confirm the Declaration. Select the CDS account that represents your shareholdings. Indicate your votes for the resolutions that are tabled for voting. Confirm and submit your votes.
4.	End of remote participation	Upon the announcement by the Chairman on the conclusion of the 87 th AGM, the Live Streaming will end.

Note to users of the RPV facilities:

- (i) Should your registration for RPV be approved, we will make available to you the rights to join the live stream meeting and to vote remotely. Your login to TIIH Online on the day of meeting will indicate your presence at the virtual meeting.
- (ii) The quality of your connection to the live broadcast is dependent on the bandwidth and stability of the internet at your location and the device you use.

ENTITLEMENT TO PARTICIPATE AND APPOINTMENT OF PROXY

- Only members whose names appear on the Register of Members as at 28 May 2024 shall be eligible to attend, speak and vote at the 87th AGM or appoint a proxy(ies) and/or the Chairman of the Meeting to attend and vote on his/her behalf.
- In view that the 87th AGM will be conducted on a virtual basis, a member can appoint the Chairman of the Meeting as his/her proxy and indicate the voting instruction in the Form of Proxy.
- If you wish to participate in the 87th AGM yourself, please do not submit any Form of Proxy for the 87th AGM. You will not be allowed to participate in the 87th AGM together with a proxy appointed by you.

VOTING

- The voting at the 87th AGM will be conducted by way of electronic voting (e-voting).
- If poll is demanded, the Company has appointed Tricor as Poll Administrator to conduct the poll by way of electronic voting (e-voting):
 - Members/proxies/corporate representatives/attorneys can proceed to vote on the resolutions at any time from the time when the poll is demanded on Tuesday, 4 June 2024 but before the end of the voting session which will be announced by the Chairman of the meeting.  - Upon completion of the voting session for the 87th AGM, the Scrutineers will verify the poll results followed by the Chairman's declaration whether the resolutions are duly passed.
